



SPECIFIC PROMOTION TERMS AND CONDITIONS FOR TITAN FX IB SOCIAL MEDIA DREAM BEYOND BORDERS ENGAGEMENT PROGRAM (2025 – 2026)

The [Titan FX IB Social Media Dream Beyond Borders Engagement Program](#) (the “Promotion”) is provided by Titan FX Limited, Titan Markets, Goliath Trading Limited and Atlantic Markets trading under Titan FX (**Titan FX**), to their Introducing Brokers (“IBs”).

By participating in this Promotion, IBs hereby acknowledge, confirm and accept to be bound by the following terms and by [Titan FX Limited’s Terms and Conditions](#) and [Titan FX IB Agreement](#).

Promotion Overview

This Promotion offers eligible IBs the opportunity to:

- Promote both Titan FX’s *Dream Beyond Borders* Campaign and Keisuke Honda (Titan FX’s Global Brand Ambassador) through Titan FX’s official social media and web-based activities.
- Earn cash rewards (not points) by completing specified posting actions during the Promotion Period.
- Participate in a monthly lottery for Keisuke Honda-signed merchandise by exceeding the minimum monthly posting target.

Promotion Period: 3rd November, 2025 JST (GMT+9) - 31st March, 2026 JST (GMT+9)

Daily Reward Limit: Maximum of one rewarded post per day per IB (across all platforms)

Monthly Reward Limit: Up to twenty (20) rewarded posts per month

Reward Delivery: Monthly - closed at the end of each month and paid by the 7th of the following month to the IB’s account in its base currency.

Reward Type: Fixed cash reward per qualifying post (1,000 JPY / approx. 6.5 USD).

1. Eligibility Criteria

1.1. To be eligible, IBs must:

- 1.1.1. Be a fully registered IB with Titan FX (KYC completed); and
- 1.1.2. not be under any special or customised commission/reward structure; and
- 1.1.3. Use a social media account with at least 100 followers; and
- 1.1.4. Be at least 18 years of age, and
- 1.1.5. Submit valid post URLs, screenshots, and IB ID via SurveyMonkey or Google Form during the Promotion Period.

1.2. Titan FX reserves the right, at its sole discretion, to determine an IB’s eligibility under these criteria. Any IB who does not meet all of the above requirements may be disqualified from the Promotion as determined solely by Titan FX.



2. Specific Offer Terms

2.1. Entry Process

To qualify for cash rewards, eligible IBs must:

- **Publish qualifying posts on social media or websites according to the reward table below.**
- **Use only official Titan FX-provided images and videos (no edits or modifications are allowed).**
- Include official hashtags (e.g., **#TitanFX #HondaKeisuke #TitanFXDreamBeyondBorders**). Submit post URLs and screenshots through the **designated online form** for verification.

2.3. Cash Rewards Redemption

- 2.3.1. Cash rewards are approved and credited monthly. Once verified by Titan FX, cash rewards will be credited to the IB account within five (5) business days as IB rebates.
- 2.3.2. IBs may receive a maximum of 20 post rewards per month.
- 2.3.3. All payments will be made directly to your Titan FX IB account.
- 2.3.4. Reward eligibility is reset each month - unused cash rewards cannot be accumulated or carried over to the next month
- 2.3.5. Details of rewards will be posted on the [Partner News page](#).

3. Posting Guidelines

- 3.1. IBs must not publish or post any material that constitutes, or could be reasonably interpreted as a direct or indirect solicitation, inducement or encouragement to engage in trading activities or to open an account.
- 3.2. All content must uphold and protect the reputation and integrity of Titan FX, its partners, and affiliated individuals or campaigns, including but not limited to Keisuke Honda and the Dream Beyond Borders campaign, and is strictly prohibited.

- 4.2.1. Entries for the bonus reward must be received by 11:59 pm (GMT+9) on the last day of each calendar month.
- 4.2.2. A random draw will be conducted by Titan FX by the 7th day of the following month to determine the winners for that period.
- 4.2.3. Winners will be contacted directly by Titan FX using the contact details provided at the time of submission. Titan FX will provide instructions to confirm bonus reward delivery arrangements.



- 4.2.4. Winners must respond to Titan FX within 14 days of notification to confirm delivery details. Failure to respond within this period may result in forfeiture of the reward, and another winner may be selected at Titan FX's discretion.

4.3. Eligibility Criteria

- 4.3.1. To be eligible, IBs must:
 - 4.3.1.1. Be a fully registered IB with Titan FX (KYC completed); and
 - 4.3.1.2. Not be under any special or customised commission/reward structure; and
 - 4.3.1.3. Use a social media account with at least 100 followers; and
 - 4.3.1.4. Be at least 18 years of age; and
 - 4.3.1.5. Submit valid post URLs, screenshots, and IB ID via SurveyMonkey or Google Form during the Promotion Period; and
 - 4.3.1.6. Be residing in Japan to qualify for the lottery draw.
- 4.3.2. Titan FX reserves the right, at its sole discretion, to determine an IB's eligibility under these criteria. Any IB who does not meet all of the above requirements may be disqualified from the Promotion as determined solely by Titan FX.

4.4. Posting Guidelines

5. Fraudulent Activity

Titan FX, at its sole discretion, can exclude an IB from participating in this Promotion:

- 5.2. The IB has not acted in good faith; and/or
- 5.3. The IB violates these terms, and/or [Titan FX's Terms and Conditions](#) and/or the [Titan FX IB Agreement](#); and/or
- 5.4. The IB submits false or misleading post URLs, personal details, or identification documents.

Titan FX reserves the right to withhold, adjust, or cancel any rewards if suspicious or unethical activity is detected, even if it does not meet the explicit definition of fraudulent activity.

6. General Conditions and Warranties

- 6.1. In participating in this Promotion, IBs agree to be bound by these terms and [Titan FX's IB Agreement](#) and [Terms and Conditions](#).
- 6.2. IBs agree that Titan FX has the right to alter, update or cancel this Promotion at any time without any prior notice or justification to the IBs.
- 6.3. IBs agree that Titan FX will not be held responsible for any consequences resulting from any alteration, update or cancellation of this Promotion.
- 6.4. IBs agree that Titan FX shall not be held responsible for any technical disruption, such as a weak internet connection, that could affect the result of the Promotion.
- 6.5. Titan FX reserves the right to refuse to offer this Promotion at its sole discretion without prior notification or justification.
- 6.6. Titan FX will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.
- 6.7. Titan FX shall not be held responsible for any system errors, technical malfunctions, or force majeure events that may impact the Promotion's execution or reward distribution.
- 6.8. This Promotion is not an offer to any person to whom it would not be lawful.
