Offer Type	IB Social Media Post Engagement Promotion This Factsheet outlines the terms of the Summer Giveaway Special IB Social Media Post Engagement Promotion. Unless otherwise stated in this Factsheet, the Titan FX IB Social Media Dream Beyond Borders Engagement Program Terms and Conditions apply. For the duration of this Promotion, the reward amounts, eligible content, eligible IBs, actions & points, posting limits, and bonus reward lottery in this Factsheet will prevail over the standard Terms and Conditions.
Promotion Description	• Share eligible Titan FX content on your social media channels and earn rewards for approved posts. • This program allows eligible IBs to promote the Summer Giveaway 2026 Promotion, “Dream Beyond Borders - Share your Dream” Campaign, and selected Titan FX content while receiving rewards for qualifying social media activity. Participants who complete ten (10) qualifying posts may also qualify for a special prize draw.

Eligible Content	Posts must meet one of the following criteria: • Summer Lottery Promotion posts: Posts that related to “Summer Giveaway 2026 Promotion” • DBB-related posts: Posts that include "Dream Beyond Borders" • Titan FX official blog/promotion posts: Posts that include “(TFX)” at the end of the caption.
Eligible IBs	All of the following conditions must be met: • Fully registered Titan FX IBs (KYC completed) • Each social media account used for posting must have at least 50 followers. • IBs under any special or customised commission/reward structure are not eligible for this Program • Be at least 18 years of age • Meet Titan FX’s eligibility requirements, as determined at Titan FX’s sole discretion
How the Program Works	1. Official Titan FX eligible content is published through our social media channels. 2. IBs post on social media using the provided materials or posts. 3. IBs submit their post URLs (with analytics screenshots showing impressions and IB code) via the Submission Form. 4. Titan FX reviews submissions of all related materials within five (5) business



	days. 5. Posts that meet all criteria are approved for cash rewards (IB rebates). 6. Approved Rewards are processed at the end of the Promotion-specific Period by IB rebates - closed at the Promotion-specific Period, paid within seven (7) business days after the Promotion-specific Period ends in the IB account's base currency.																		
Posting Rules	• Maximum 2 rewarded posts per day per IB (across all platforms). • During this Promotion only, the standard monthly limit of twenty (20) rewarded posts does not apply. Instead, IBs may receive rewards for a maximum of thirty (30) qualifying posts during the Promotion Period. • Duplicated or repetitive content is not eligible. • Only official Titan FX-provided materials may be used (no edits or modifications). • Only original posts and quote reposts (with added commentary) are eligible. Simple reposts (including repost/retweet without comment) are not eligible for rewards under this Promotion. • Posts or content that may cause harm/damage to the reputation or image of Titan FX, Honda, or Dreamers are strictly prohibited. • Deleted or hidden posts are disqualified from reward eligibility. • Only the primary IB account is eligible (secondary accounts will not be counted).

Impressions must be based on platform-native analytics (e.g., X Post Analytics). All submitted posts must include corresponding analytics screenshots clearly showing the number of impressions. Titan FX reserves the right to reject any submissions where: • Impression data is unclear or cropped • Screenshots appear altered or manipulated • The data cannot be reasonably verified												
Bonus Reward - Special Lottery	IBs who make ten (10) qualifying posts during the Promotion Period (meeting all program rules) will be entered into a one-time lottery to win exclusive Keisuke Honda merchandise or Titan Point Club points. 	Additional Conditions: • Winners of Titan Point Club points must hold an active Titan FX Live Trading Account at the time the reward is credited. Process: • IBs who make ten (10) qualifying posts during the Promotion Period, submit all required post details via the Submission Form, and meet all program requirements will be automatically entered into the prize draw. • Eligibility for the prize draw will be determined based on all qualifying submissions received during the Promotion Period. • The prize draw will be conducted by Titan FX within seven (7) business days after the Promotion-specific Period ends. • Winners will be contacted directly for delivery arrangements. • Winners must respond to Titan FX within fourteen (14) days of notification to confirm delivery details. Failure to respond within this period may result in forfeiture of the reward, and another winner may be selected at Titan FX's discretion. • If identical or similar content is shared across multiple social media platforms, each individual post will count toward the ten (10) - post minimum requirement, provided that all posts adhere to the program guidelines. This applies only to the bonus reward. • "Qualifying posts" refers only to posts that meet all requirements under this Factsheet, including the impression threshold condition. • Only IBs residing in Japan are eligible for the lottery draw. The Bonus Reward - Special Lottery described above applies only during the Summer Giveaway Special IB Social Media Post Engagement Promotion Period.
Reporting & Verification	IBs must submit: • Post URL • Screenshot of the post and a screenshot of the post analytics page clearly showing the impression count • IB Code Titan FX reviews submissions within five (5) business days. Submissions without verifiable impression data will be rejected. Approved posts will be counted toward reward eligibility.
